



## **118<sup>th</sup> Congress in Review: Securing America at Home and Abroad**

5. **The CCP's Role in the Fentanyl Crisis:** Select Committee investigators revealed how Chinese authorities not only looked the other way, but actively subsidized the production and export of fentanyl to the United States, even protecting those involved from law enforcement.
6. **Rebuilding the Arsenal of Democracy: The Imperative to Strengthen America's Defense Industrial Base and Workforce:** Three expert witnesses from industry and academia discussed ways to rebuild America's defense industrial base.
