2	This Act may be cited as the "Retroactive Foreign
3	Agents Registration Act".
4	SEC. 2. CLARIFYING OBLIGATION TO REGISTER RETRO-
5	ACTIVELY AS AGENTS OF FOREIGN PRIN-
6	CIPALS.
7	(a) Obligation.—The third sentence of section 2(a)
8	of the Foreign Agents Registration Act of 1938, as
9	amended (22 U.S.C. 612(a)) is amended by striking "for
10	the period" and inserting "covering the period".

3	(2) by striking the period at the end and insert-
4	ing the following: ", including an order requiring a
5	person to comply with section 2 with respect to any
6	period during which the person acts as the agent of
7	a foreign principal notwithstanding that the person
8	does not act as the agent of a foreign principal at
9	the time the court issues the order.".
10	(b) Effective Date.—The amendment made by

14	any time before, on, or after the date of the enactment
15	of this Act.
